**WYSIGING VAN WATERBEPERKINGS: BEAUFORT-WES // AMENDMENT OF WATER RESTRICTIONS: BEAUFORT WEST // IMIGAQO YOKONGA AMANZI: BHOBHOFOLO**

Kennis geskied hiermee ingevolge Artikel 46(1) van die Verordening insake Watervoorsiening, Kennisgewing Nr. 148/2005 dat die volgende waterbeperkings met ingang **1 April 2021** ten opsigte van Beaufort-Wes toegepas sal word:-

1. Fase 1 waterbeperkings met dien verstande dat indien daar 'n drastiese afname in die watertafel van boorgate ervaar word, waterbeperkings hersien sal word.
2. Dat fase 1 watertariewe ten opsigte van waterbeperkings vervat in die 2020/2021 tariewe vanaf 1 April 2021, toegepas sal word.
3. Dat ingevolge Artikel 46(1)(c) van die Verordening insake Watervoorsiening, Kennisgewing 148/2005, steeds van toepassing sal wees op die gebruik van tuinslange in Beaufort-Wes vir die natmaak van tuine, was van motors, volmaak van swembaddens en of damme vir enige ander sodanige doel waarvoor 'n tuinslang aan die munisipale watervoorsieningstelsel gekoppel moet word.

Notice is hereby given in terms of Section 46(1) of the By-Law relating to Water Supply, Notice No. 148/2005 that the following water restrictions applied to Beaufort West with effect from **1 April 2021**:-

1. Phase 1 water restrictions provided that if a drastic decrease is experienced in the water table of boreholes, water restrictions will be reviewed.
2. That phase 1 water tariffs in respect of water restrictions contained in the 2020/2021 tariffs from 1 April 2021, will be applied.
3. That in terms of Section 46(1)(c) of the Water Supply By-law, Notice 148/2005, it will continue to apply to the use of garden hoses in Beaufort West for the watering of gardens, washing of cars, full of swimming pools and or dams for any other such purpose for which a garden hose must be connected to the Municipal water supply system.

Kukhutshwa isaziso esikhutshwa ngokweCandelo lama (46(1) loMthetho kaMasipala woNikezelo lwaManzi, iSaziso No.148/2005 ukuba ezi zithintelo zamanzi zilandelayo ziya kusetyenziswa ngokubhekisele eBhobhofolo ukusukela ngomhla woku-1 ku Apreli 2121:

1. Isigaba 1 sezithintelo zamanzi ngaphandle kokuba ukuba kukho ukwehla okukhulu kuluhlu lwamanzi amaqula, izithintelo zamanzi ziya kujongwa kwakhona.
2. Kuya kusetyenziswa irhafu yesigaba-1 yamanzi ngokumalunga nezithintelo zamanzi eziqulethwe kwirhafu zika 2020 / 2021 ukususela ngomhla woku-1 ku-Aprili 2021.
3. Ukuba ngokweCandelo 46(1)(c) loMthetho kaMasipala woNikezelo lwaManzi, iSaziso no: 148/2005, uyakuqhubeka ukufaka isicelo ekusetyenzisweni kwemibhobho yegadi eBhobhofolo yokuncenkeshelwa kwegadi, ukuhlanjwa kwe moto, ukugcwalisa amachibi okuqubha kunye namadama kuyo nayiphi na enye injongo apho isezakuhlala kunyanzeliswa ukusetyenziswa kwemobhobho yegadi eBhobhofolo wegadi kufuneka uqhagamshelwe kwinkqubo yonikezelo lwamanzi kaMasipala.
