Kennisgewing geskied hiermee ingevolge Paragraaf 27 van die 2022/2023 Kredietbeheer- en Skuldinvorderingsbeleid van Beaufort-Wes Munisipaliteit, dat die Munisipaliteit op 16 November 2022 elektrisiteit ten opsigte van vooruitbetaalmeters ten volle sal blokkeer. Tot die 15^{de} November 2022 sal elektrisiteit gedeeltelik blokkeer word. Die publiek word versoek om te verseker dat hul munisipale rekening op datum betaal word om te verseker dat die dienste nie beperk word nie. The public is also advised to visit the Credit Control Offices at 15 Church Street, Beaufort West to make down payment arrangements, should they not be able to pay the full outstanding amount.
