NOTICE FOR INDIGENT REGISTRATION: 2022/2023

Kindly be informed, that in terms of the Indigent Policy, the indigency relief shall apply for a period, not extending beyond the financial year, for which the particular household is registered as indigent. Registration must be renewed for each financial year, if relief is to continue in such year. The application process is open for the financial year 2023/24.

Therefore, all consumers are required to make new applications.

The indigent application process will be done per Area for a week. Our officials will be based at the following premises from 13 February 2023 till 17 March 2023 (8:00 -16:00) at the following venues:

After the Area visits as stated above, you are still welcome to come to Beaufort West Municipality Office (INDIGENT OFFICE at Thusong Centre) to apply or renew your indigent registration.

Please bring with the following documents:

- Copy of ID (of all residents residing on the property older than 18 years). Person must be a South African citizen;
- Proof of property ownership;
- If Tenant, a sworn affidavit from Owner that you may occupy the premises or Death certificate of owner and their Certified ID copy.

If you are employed, include the following in your application:

- latest salary/wage payslip or a letter from your employer stating your income;
- if you are self-employed, a sworn affidavit stating how much you earn per month with your bank statement; and;
- proof of receipt of a disability grant, maintenance grant or pension. Letter from SASSA confirming receipt of grant or bank statement.

If you are unemployed, include the following in your application:

- a sworn affidavit stating that you are unemployed; and
- a sworn affidavit stating that you have no other source of income.

The household income may not exceed the total of 2x All Pay Pension.

The property may only be used for residential purposes.

The applicant must be a permanent resident of Beaufort West, Merweville, Nelspoort or Murraysburg.

Must be a South African Citizen.

The applicant may not be a registered owner of more than one property.

A person who provides false or misleading information will be disqualified and be refused further participation in the subsidy scheme. In addition, he/she may be held liable for the immediate repayment of any subsidies already granted and legal action may be instituted against the guilty party/ parties.

Applicants, whose municipal accounts are in arrears, at the time of the application for a subsidy, will have to make arrangements with the Municipality for paying off the amounts in arrears.
