**VOORGESTELDE VERHURING VAN 'N GEDEELTE VAN ERF 249 MURRAYSBURG, GROOT ONGEVEER 1 HA // PROPOSED LEASE OF A PORTION OF ERF 249 MURRAYSBURG, MEASURING APPROXIMATELY 1 HA**
