

1) If a consumer uses more than 15kl during Phase 3 Restrictions, a surcharge of 100% will be charged on the consumption part of the account.

- 2) If a consumer uses more than 10kl during Phase 4 Restrictions, a surcharge of 200% will be charged on the consumption part of the account.
- 3) If a consumer uses more than 6kl during Phase 4 Restrictions, a surcharge of 250% will be charged on the consumption part of the account.

#### **Restriction application Model**

A new model for the application of Water Restrictions has been drawn up in accordance with the guidelines contained in the Provincial Gazette Extraordinary No. 7811 of Monday, August 21, 2017. The model determines the monthly water consumption versus water availability and makes recommendations on which Phase of Restrictions are required.

It is recommended that where consumption is less than availability, the next level of restrictions be adopted by the council within a month and where the availability of water begins to improve over a three-month period, the restriction is relaxed. - 10.1.7 Certificate of Acceptability for Fire Safety issued in terms of the Fire Brigade Services Act, Act 99 of 1987 and the "Standard Community Fire Safety By-Law" Provincial Notice 342/200 (P/M 342-2006) 27 Oct 2006 Gazette 6389.
- 10.2 That the undermentioned protocols be excluded or exempted from the tariffs and for the or Chief: Fire Services / Superintendent: Fire Services: -
  - 10.2.1 When a false alarm has been received but the responsible person, in the opinion of the Chief Fire Officer, acted in good faith, no charges shall be applicable.
  - 10.2.2 Council withholds the right to revoke all charges relating to: Civil Commotion Riots Natural Disasters Either locally or on request of another sphere of Government.
  - 10.2.3 No charges shall be applicable to any registered indigents.
  - 10.2.4 Bona fide charitable organizations may be exempted from any charges.
  - 10.2.5 Should new training courses be developed the Head of Community Safety be allowed to implement an appropriate interim tariff until the next financial year.
  - 10.2.6 Exercises, where such exercises are requested and initiated by the Beaufort West municipality Fire Services.
