### CALL FOR NOMINATIONS OF PUBLIC PERSONS TO BE APPOINTED AS A MEMBER OF THE MUNICIPAL PLANNING TRIBUNAL FOR BEAUFORT WEST MUNICIPALITY

Beaufort West Municipality must appoint new members to serve on the Municipal Planning Tribunal. The Tribunal will be responsible for taking decisions on categories of land use and land development applications as designated by the Municipality.

The Municipal Planning Tribunal will consist of members of the public and officials with knowledge and experience of spatial planning, land use management, land development and the law related thereto. Responsibilities will include preparing for meetings by reading reports, attendance and participation at meetings of the Tribunal, attending site inspections and other duties and functions provided for in legislation.

Interested parties are invited to submit nominations for members who have knowledge, experience and/or qualifications in one or more of the aforementioned fields and must be in possession of a valid Fidelity Fund Certificate issued by the Legal Practice Council of South Africa or be a qualified non-practicing attorneys in services of an organ of state to be appointed to the Beaufort West Municipality Municipal Planning Tribunal for its first term of office. Members will be appointed for a term of five (5) years, subject to terms and conditions. For ordinary members it is a part-time position. It is estimated that the Municipal Planning Tribunal will meet four times per year depending on the number of matters to consider, with remuneration determined by National Treasury in terms of Treasury Regulations.
