**HERAANWEND VAN EKSTERNE LENING //
RE-ALLOCATED OF EXTERNAL LOAN**



Kennis geskied hiermee ingevolge Artikel 46(3)(a) van die Wet op Munisipale Finansiële Bestuur, Wet 56 van 2003, dat die Munisipaliteit van Beaufort-Wes van voorneme is om die eksterne lening soos gepubliseer per kennisgewing no. 102/2014 her aan te wend:

Die Beaufort-Wes Munisipaliteit het gedurende die jaar 'n lang-termyn lening opgeneem ten bedrae van R2.46 miljoen wat deels ten doel gehad het vir die aankoop van 'n kraan trok vir die Departement: Ingenieursdienste ten bedrag van ongeveer R900,000.00. As gevolg van 'n drastiese verandering in omstandighede wil die Munisipaliteit nou die fondse liewer aanwend om die ingangspad by die industriële area te herbou.

Kennisgewings is ook gestuur aan Nedbank, Provinsiale Tesourie en Nasionale Tesourie.

Verdere besonderhede lê gedurende kantoorure ter insae by die Kantoor van die Direkteur: Finansiële Dienste, Kerkstraat 15, Beaufort-Wes. Die publiek is welkom om enige kommentaar of teenkantings in te dien by die Kantoor van die Munisipale Bestuurder, Donkinstraat 112, Beaufort-Wes teen nie later nie dan **Vrydag, 30 Oktober 2015**.

Notice is hereby given in terms of Section 46 (3)(a) of the Municipal Finance Management Act, Act 56 of 2003 that the Beaufort West Municipality intends to re-allocated the external loan published by Notice No. 102/2014:

The Beaufort West Municipality acquired a long term loan of R2.46 million during the year, which included an amount of R900,000.00 for the purpose of purchasing a crane truck for the Department: Engineering Services. Due to the drastic change in circumstances the Municipality now instead wish to use the funding for the rebuilding of the entrance road into the industrial area.
