Bids are invited by the Municipal Manager of BEAUFORT WEST MUNICIPALITY for the **upgrading & refurbishment of existing primary sub stations of Beaufort West for a period of 3 years.**

It is estimated that the Tenderers for the main contract should have a CIDB contractor grading designation of **5EP or higher. A prerequisite of 75% is determined for functionality in order to be evaluated on price.**

Documents will only be available for collection at the compulsory site inspection meeting if tenderers booked their tender documents in advance **2 days** before the site inspection. A compulsory site inspection meeting will be held at the **Offices of the Director: Electro Technical Services, Loch Road, Beaufort West** at **11:00** on the **25 FEBRUARY 2016**, where representatives of the Employer will take the prospective tenderers to the site of the works. **No tenderers will be allowed to attend the compulsory site inspection meeting after 11:10.**

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (ninety) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2011. The 90/10 preference points system will be applicable.
