NOMINATED SUB-CONTRACT FOR THE UPGRADING OF PROTEA & OAK STREET

Bids are invited by the Municipal Manager of BEAUFORT WEST MUNICIPALITY for nominated sub-contracts for the upgrading of **Protea & Oak Street**. **The scope of works consists of the construction of approximately 800 m Road, depending on tender prices.**

It is estimated that the sub-contractor should have a CIDB contractor grading designation of 1CE or higher. It is a requirement that tenderers for the sub-contracts are registered with SARS as a business and that a tax clearance certificate and proof of registration on the Database of the Beaufort West Municipality must be provided with the completed tender documentation and only nominated sub-contractors that are based within the borders of the Beaufort West Municipality will be allowed to tender.

Documents will only be available for collection at the compulsory site inspection meeting if tenderers booked their tender documents 2 days in advance before the site inspection. Any person desiring to be present may attend.

A compulsory site inspection meeting will be held at the **Office of the Director: Engineering Services, 61 Bird Street, Beaufort West** at **10:00** on the **31 August 2016**, where representatives of the Employer will take the prospective tenderers to the site of the works. **No tenderers will be allowed to attend the compulsory site inspection meeting after 10:10 am.**

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (ninety) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2011.
