Bids are invited by the Municipal Manager of the BEAUFORT WEST MUNICIPALITY from Electrical Service Providers to **PERFORM MAINTENANCE OF ELECTRICAL INSTALLATIONS (1) PUMP STATIONS and EXTENSIONS and MAINTENANCE OF ELECTRICAL WIRING: BUILDINGS OF BEAUFORT WEST MUNICIPALITY FOR A PERIOD OF 3 YEARS.**

It is estimated that the contractor should have a CIDB contractor grading designation of 3 EB or higher. A prerequisite of 75 % exist for Functionality, in order to be further evaluated. It is a prerequisite that tenderers must have previous experience of Spectrum Communications Telemetry systems. Bidder must be an established electrical contractor situated within a radius of 30km from Beaufort – West to ensure effective service delivery.

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (ninety) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2011.
