**UPGRADING OF GRAVEL ROADS: BLANKEN WAY (HILLSIDE): BEAUFORT WEST**

The BEAUFORT WEST MUNICIPALITY hereby invites contractors to submit formal written tenders for the **Upgrading of Gravel Roads: Blanken Way (Hillside): Beaufort West**.

**It is estimated that the contractor should have a CIDB grading designation of 6CE or higher.**

**A prerequisite of 70 evaluation points exists for Quality/ Functionality, in order to be further evaluated.**

**A compulsory site meeting will be held at the Conference Room at Electro-Technical Services, Lock Road, Beaufort West on Thursday, 22 May 2025 at 14h00. No bidders will be allowed to attend the compulsory site inspection meeting if they arrive more than 15 minutes after the meeting commenced.** Hard copies of bid documents must be booked in advance before Monday, 19 May 2025 before 14h00 and will be available at the compulsory clarification meeting. A non-refundable fee of R350.00 (Three hundred and Fifty Rand), is payable for a set of printed documents. The fee must be deposited into the account of the **Beaufort West Municipality** at **NEDBANK**, Branch Code: 198765, Account Number **107 428 0318**. The reference number for confirmation of payment is: **SCM 35/2025** and bid documents will be made available upon provision of proof of payment.

Sealed bids, marked: **"SCM 35/2025: Upgrading of Gravel Roads: Blanken Way (Hillside): Beaufort West"** must be addressed to the Municipal Manager and placed in the tender box at the Office of the Supply Chain Management Unit in the Sanlam Building, 112 Donkin Street, Beaufort West, before the closing time and date of **14:00 on Friday, 13 June 2025**. Tender documents will then be opened in the presence of anyone who wishes to attend, in the Committee Room in the Supply Chain Management Office at the Sanlam Building, Donkin Street, Beaufort West.

The evaluation of this bid will be subjected to functionality scoring. Tenderers must achieve a minimum functionality score of 70 out of 100 points for functionality in order to be evaluated further. The functionality criteria and weighting are set out in the tender document. Pre-evaluation criteria and weight:

1. Company (or JV) General Experience carrying a weight of 40 points
2. Relevant references carrying a weight of 30 points
3. Key Staff and Personnel carrying a weight of 30 points

Telegraphic, telephonic, telex, facsimile, e-mail and late tenders will not be accepted. The lowest, only or any tender shall not necessarily be accepted and the Council reserves the right to accept any part of the tender.

Bids must be submitted on the original documents and must be valid for a period of 90 (ninety) days after the closing date. The tender will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations 2023. The 80/20 preference points system will be applicable.

**Notwithstanding the period for validity of bids as set out in the bid documents, bids shall be deemed to remain valid until formal acceptance by the Beaufort West Municipality of an offer at any time after the expiry of the original validity period, unless the Beaufort West Municipality is notified in writing of anything to the contrary (including any further conditions) by the bidder.**

It is prerequisite that all prospective service providers who are not yet registered on the Central Supplier Database; register without delay by completing the prescribed form. Application forms are obtainable on their website [www.csd.gov.za](http://www.csd.gov.za).
