The BEAUFORT WEST MUNICIPALITY hereby invites contractors to submit bids for the CIVIL CONSTRUCTION AND ASSOCIATED WORKS FOR THE UPGRADING OF THE NELSPOORT WATER TREATMENT WORKS.

It is estimated that the contractor should have a CIDB grading designation of 6CE or higher.

A prerequisite of 70 evaluation points exists for Quality/ Functionality, in order to be further evaluated.

A compulsory site meeting will be held at the Nelspoort Water Treatment Works, Nelspoort on Friday, 20 June 2025 at 11:00. No tenderers will be allowed to attend the compulsory site inspection meeting if they arrive more than 15 minutes after the meeting commenced. Tender documents will then be opened in the presence of anyone who wishes to attend, in the Committee Room in the Supply Chain Management Office at the Sanlam Building, Donkin Street, Beaufort West.

Telegraphic, telephonic, telex, facsimile, e-mail and late tenders will not be accepted. The lowest, only or any tender shall not necessarily be accepted and the Council reserves the right to accept any part of the tender.

The tender must be valid for a period of 90 (ninety) days after the closing date. The tender will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2023. The 80/20 preference points system will be applicable.
