The Beaufort West Municipality Hereby invites Contractors to submit bids for the design, supply and installation of mechanical & electrical works for the upgrading of the Beaufort West wastewater treatment works.

It is estimated that the contractor should have a CIDB grading designation of 6ME or higher.

A prerequisite of 70 evaluation points exists for Quality, in order to be further evaluated.

A compulsory site meeting will be held at the *Beaufort West Wastewater Treatment Works, Beaufort West* on Wednesday, 25 February 2026 at 12:00. No tenderers will be allowed to attend the compulsory site inspection meeting if they arrive more than 15 minutes after the meeting commenced. Hard copies of the document must be booked in advance before Thursday, 19 February 2026 and will be available at the compulsory site meeting and bookings can be done with Mr. S Madumbo at sidwillm@beaufortwest.gov.za.

Tender documents will then be opened in the presence of anyone who wishes to attend, in the Committee Room in the Supply Chain Management Office at the Sanlam Building, Donkin Street, Beaufort West.

Telegraphic, telephonic, telex, facsimile, e-mail, bids not completed in black ink by hand and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and Beaufort West Municipality reserves the right to accept any part of the bid. The bid must be valid for a period of 90 (Ninety) days after the closing date.

The bid will be subject to Council's Supply Chain Management and Preferential Procurement Policies. The 80/20 preference points system will be applicable. A maximum of 80 points will be awarded for Price and a maximum of 20 points will be awarded for the following Specific Goals:
