**VERDERE WATERBEPERKINGS // ADDITIONAL WATER RESTRICTIONS //  
IMIQATHANGO YOKUSETYENZISWA KWAMANZI EYONGEZELEKILYO**

Kennisgewing geskied hiermee ingevolge Artikel 46(1) van die Verordening insake Watervoorsiening, Kennisgewing 148/2005 dat die Munisipaliteit met ingang **1 JULIE 2017** die volgende verdere waterbeperkings sal instel ten opsigte van Beaufort-Wes:-

1. Dat fase 4 waterbeperkings sal inwerking tree, indien dit nie voldoende reën nie.
2. Dat die algehele verbod wat met ingang 1 Februarie 2017 ingestel was, word op die gebruik van tuinslange in Beaufort-Wes vir die natmaak van tuine, was van motors, volmaak van swembaddens en of damme en vir enige ander sodanige doel waarvoor 'n tuinslang aan die munisipale watervoorsieningstelsel gekoppel moet word, behou word
3. Dat die inwoners wie gebruik maak van boorgate, aandui voor die huis dat hulle van boorgatwater gebruik maak.

Vir algemene inligting beteken fase 4 waterbeperkings dat dieselfde tariewe soos van toepassing op fase 3 waterbeperkings gehef sal word, maar indien 15 kiloliter oorskry word 'n toeslag van 200 % op die verbruik van die waterrekening gehef sal word.

Notice is hereby given in terms of Section 46(1) of the By-Law relating to Water Supply, Notice 148/2005 that the Municipality will impose the following additional water restrictions for Beaufort West with effect from **1 JULY 2017**:-

1. That stage 4 water restrictions will come into force if sufficient rainfall does not occur.
2. That the total ban introduced with effect from 1 February 2017 on the use of garden hose in Beaufort West for the watering of gardens, wash of cars, refill of swimming pools and or dams and for any other purpose for which a hose must be linked to the municipal water supply system, remain in force.
3. That all residents whom are using water from boreholes, must put up applicable signage at their premises indicating the use of borehole water.

For general information, phase 4 water restrictions mean that the same tariffs as applicable to phase 3 water restrictions will be charged, but if 15 kiloliters are exceeded a 200% surcharge will be charged on the consumption of the water account.

Kukhutshwa isaziso ngokwemigaqo yomthetho yecandelo lama-46 (1) ezinxulumene namanzi, iSaziso 148/2005 ukuba umasipala uza kumisela imiqathango yokusetyenziswa kwamanzi elandelayo eyongezelelweyo kuMasipala waseBhobhfofo ukususela ngomhla woku-1 **JULAYI 2017**:-

1. Ukuba imvula ayin ngokwaneleyo uiqathango we4 woqoqosho lwamanzi uyakunyanzeleka usetyenziswe.
2. Ukususela ngomhla wokuqala kuFebawari 2017 kuyavalwa ukusetyenziwa ukuncencesheleni imiyezo, ukuhlajwa kwemoto okanye amachibi okudada okanye amadama okanye nayiphi na injongo usebenzisa amanzi ekwenzeni ezizinto kufuneka inxulunyanise ne nenkqubo yonikezelo lwamanzi kamasipala izohlala isebenza.

3. Bonke abahlali abasebenzisa amaqula, kufuneka abeke imiqondiso echazayo kwiindawo zabo.

Ulwazi jikelele, Uluhlu lwamaxabiso esigabe se 4 zothintelo lwamanzi ayafana nawe sigaba sesi 3 zothintelo lwamanzi, Ukuba udlulisile ekusebenziseni iikhillitha ez15 uyakuhlaliswa i200% eyongenziweyo kwi akhawunti yakho yamanzi.
