**VERDERE WATERBEPERKINGS // FURTHER WATER RESTRICTIONS // EMINYE
IMIQATHANGO YOKONGA AMANZI**

Kennis geskied hiermee ingevolge Artikel 46(1) van die Verordening insake Watervoorsiening, Kennisgewing Nr. 148/2005 dat die Plaaslike Raad op 1 Augustus 2018 besluit het dat die volgende waterbeperkings met ingang **1 September 2018** ten opsigte van Beaufort-Wes toegepas sal word:-

1. Dat ingevolge Artikel 46(1)(b)(i) van die Verordening insake Watervoorsiening, Kennisgewing Nr. 148/2005, die toegelate waterverbruik per huishouding per maand tot 10 kiloliter beperk word.
2. Dat fase 4 watertariewe ten opsigte van waterbeperkings vervat in die 2018/2019 tariewe, toegepas word.
3. Dat indien 'n verbruiker meer as 15 kiloliter per maand gebruik, daar ingevolge Artikel 46(4)(a) van die Verordening insake Watervoorsiening 'n vloeibeheerstelsel by sodanige verbruiker installeer word, nadat 'n skriftelike waarskuwing aan sodanige verbruiker beteken is.

Notice is hereby given in terms of Section 46(1) of the By-Law relating to Water Supply, Notice No. 148/2005 that the Local Council on 1 August 2018 resolved that the following water restrictions applicable to Beaufort West will be imposed with effect from **1 September 2018**:-

1. That in terms of Section 46(1)(b)(i) of the By-Law relating to Water Supply, Notice No. 148/2005 that allowed water usage per household per month by reduced to 10 kilolitre.
2. That phase 4 water tariffs relating to water restrictions contained in the 2018/2019 tariffs will be applied.
3. That if a consumer's water usage exceeds 15 kilolitre per month, a flow control device will be installed in terms of Section 46(4)(a) of the By-Law relating to Water Supply, after a notice has been served on such consumer.

Umasipala waseBhobhofolo uphumeze imiqathango yokusetyenziswa kwamanzi ngomhla we 01 August 2018 ukuqinisekisa ukhuseleko lwamanzi aseBhobhofolo. Lemiqathango iqulathwe kwisolotya 46(1) eliku mgaqo nkqubo No 148/2005. Lemiqathango iyakuqala ukusebenza ngomhla woku-**1 September 2018**.

1. Bonke abasebenzisi bamanzi bayakuthotyelwa ilitha ezilishumi zamanzi umzi ngamnye nyanga zonke.
2. Uphase 4 oqulathe ixabiso lokulondolozwa kwamanzi uyakusetyenziswa. Mqulu lowo uqulathwe kwixabiso lamanzi lika 2018/2019 likamasipala.
3. Ukuba umhlali wasebhobhofolo usebenzise iilitha ezingaphezu kwe 15 kilolitres zamanzi kamasipala ngenyanaga. Kuyakuthi kunyanzeliswe umthetho ngokwesolotya lika 46(4)(a) elikumgaqo nkqubo yosebenziso lamanzi. Konke oko kuyakwenziwa xa umhlali ethe wanikwa incazelo ngumasipala malunga nokusetyenziswa kwamanzi gwenxa.
