The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid. Bids must be submitted on the original documents and must be valid for a period of of 120 (one hundred and twenty) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017. The 80/20 preference points system will be applicable.
