The BEAUFORT WEST MUNICIPALITY hereby invites service providers to submit formal written tenders to be appointed to a panel for the following services: **PROFESSIONAL ENGINEERING SERVICES PANEL FOR ROADS AND STORM WATER INFRASTRUCTURE FOR A MULTI-YEAR PERIOD.**

**A compulsory clarification meeting will be held on Thursday, 10 July 2025 at 11h00 at Conference Room at Electro-Technical Services, Loch Street, Newtown, Beaufort West. No Tenderers will be allowed to attend the compulsory site inspection meeting if they arrive more than 15 minutes after the meeting commenced.**

Only those Tenderers who have in their full time employ a person registered as a **Professional Engineer (Pr Eng)** or **Professional Engineering Technologist (Pr Tech Eng)** in terms of the Engineering Professions Act, 2000 (Act No 46 of 2000) AND Only Tenderers who can demonstrate that they will have in their employ staff which satisfy EPWP requirements during the contract validity are eligible to submit tenders.

Tenderers need to meet the minimum threshold for **Functionality/Quality** as stated in the Tender Data to be considered for further evaluation.

Formal written tenders will then be opened in the presence of anyone who wishes to attend, in the Committee Room in the Supply Chain Management Office at the Sanlam Building, Donkin Street, Beaufort West.

Telegraphic, telephonic, telex, facsimile, e-mail and late tenders will not be accepted. The lowest, only or any tender shall not necessarily be accepted and the Council reserves the right to accept any part of the tender.

The tender must be valid for a period of **90 (Ninety)** days after the closing date.

The tender will be subject to Council's Supply Chain Management and Preferential Procurement Policies. The 80/20 preference points system will be applicable. A maximum of 80 points will be awarded for Price and a maximum of 20 points will be awarded for the following Specific Goals:
