The Beaufort West Municipality hereby invites Consulting Engineering Services for the upgrading and extension of all electrical reticulation, bulk electrical services and lighting projects within the jurisdiction area of Beaufort West Municipality which includes the towns of Beaufort West, Murraysburg, Nelspoort and Merweville for a period of 3 years.

A prerequisite of 75% exist for functionality, in order to be evaluated on price and preference points.

A compulsory site meeting will be held at the offices of the Beaufort West Municipal Electrical Department situated in Loch Road, Beaufort West on WEDNESDAY, 18 AUGUST 2021 at 11:00. No tenderers will be allowed to attend the compulsory site inspection meeting if they arrive more than 15 minutes after the meeting commenced. Bids will then be opened in the presence of anyone who wishes to attend, in the Committee Room at the Supply Chain Management Unit at the Sanlam Building, 112 Donkin Street, Beaufort West.

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

Bids must be submitted on the original documents and must be valid for a period of 90 (ninety) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017. The 80/20 preference points system will be applicable.
