Bids will then be opened in the presence of anyone who wishes to attend in the Committee Room in the Supply Chain Management office at the Sanlam Building, Donkin Street, Beaufort West.

Bids received in electronic format or after the closing time and date will not be considered. Council is not bound to accept the lowest or any late bids will not be accepted.

The bid must be valid for a period of 120 (One hundred and twenty) days after the closing date. Bids may only be submitted on the bid documentation issued by Beaufort West Municipality. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017. The 80/20 preference points system will be applicable.
