The BEAUFORT WEST MUNICIPALITY hereby invites service providers to submit formal written tenders for:
PROFESSIONAL ENGINEERING SERVICES FOR ROADS AND STORM WATER INFRASTRUCTURE FOR THE PERIOD ENDING 30 JUNE 2025.

A compulsory clarification meeting will be held on Tuesday 27 September 2022 at the Rustdene Hall De Vries Street 11:00. No tenderers will be allowed to attend the compulsory site inspection meeting if they arrive more than 15 minutes after the meeting commenced.

Only those tenderers who have in their full time employ a person registered as a **Professional Engineer (Pr Eng)** or **Professional Engineering Technologist (Pr Tech Eng)** in terms of the Engineering Professions Act, 2000 (Act No 46 of 2000) AND Only tenderers who can demonstrate that they will have in their employ staff which satisfy EPWP requirements during the contract validity are eligible to submit tenders.

Tenderers need to meet the minimum threshold for Functionality/Quality as stated in the Tender Data to be considered for further evaluation.

Formal tenders will then be opened in the presence of anyone who wishes to attend, in the Committee Room in the Supply Chain Management Office at the Sanlam Building, Donkin Street, Beaufort West.

Telegraphic, telephonic, telex, facsimile, e-mail and late tenders will not be accepted. The lowest, only or any tender shall not necessarily be accepted and the Council reserves the right to accept any part of the tender.

The tender must be valid for a period of **120 (One hundred and twenty)** days after the closing date.

The tender will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017. The 80/20 preference points system will be applicable.
