UPGRADING OF EXISTING PAVILION AT BEAUFORT WEST RUGBY FIELD

Bids are invited by the Municipal Manager of Beaufort West Municipality for tender the Upgrading of existing pavilion at Beaufort West Rugby Field.

Beaufort West Municipality invites tenderers for the upgrading of the above stated. The Scope of Works will include (but is not limited to) the reconstruction of the pavilion roof structure, roof covering, alterations of substructure, walls, etc.

It is estimated that the Tenderers for the main contract should have a CIDB contractor grading designation of **3GB or higher**.

Documents will only be available for collection at the compulsory site inspection meeting and prospective bidders must book their tender documents in advance 2 days before the site inspection. Any person desiring to be present may attend.

A compulsory site inspection meeting will be held at the **Offices of the Acting Director: Engineering Services, 61 Bird Street, Beaufort West** at **11:00** on the **Thursday, 15 November 2018**, where representatives of the Employer will take the prospective tenderers to the site of the works. **No tenderers will be allowed to attend the compulsory site inspection meeting after 11:15.**

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (ninety) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017. Local content requirements is 50-100% applicable to bid document.
