Beaufort West Municipality wishes to lease office space in the Central Business District (CBD) of Beaufort West to be used as municipal offices for a period of 3 years as from 1 January 2021 or a date mutually agreed upon by the successful bidder and the Municipality.

A prerequisite of 75% exist for functionality, before bids will be evaluated for price and preference points.

Documents will only be available for collection at the compulsory clarification meeting if tenderers booked their tender documents in advance before the clarification meeting. No tenderers will be allowed to attend the compulsory clarification meeting after 11:15 am.

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

Bids must be submitted on the original documents the bid must be valid for a period of 120 (one hundred and twenty) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Amended Preferential Procurement Regulations, 2017. The 80/20 preference points system will be applicable.
