It is estimated that the Tenderers for the main contract should have a CIDB contractor grading designation of **3ME or higher**. **A prerequisite of 75 % exist for Functionality, in order to be further evaluated.**

Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 90 (ninety) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2011.
