Documentation fee:	A non-refundable tender deposit of R371 (three-hundred and seventy one rand) payable in cash or EFT made out in favour of the Employer is required on collection of the tender documents. Bid Number to be used as payment reference with the name of payee.				
Document submission:	Tenders must only be submitted on the tender documentation that is issued.				
Eligibility requirements: (CIDB)	It is estimated that tenderers must have a CIDB contractor grading of 5CE or higher. Only Tenderers who are registered with CIDB in the appropriate Contractor grading designation are eligible to submit tenders.				
Eligibility requirements: (LIC)	Only tenderers who can demonstrate that they will have in their employ staff which satisfy EPWP requirements during the contract validity are eligible to submit tenders				
Quality/Functionality requirements:	Tenderers need to score a minimum of 70 out of 100 points for Quality to be evaluated further on Price and Preference.				
Preferences:	Preferences are offered to Tenderers based on their B-BBEE Status Level of Contributor (10 points) and Locality of service provider (10 points).				
Clarification Meeting:	A compulsory clarification meeting with representatives of the Employer will take place in the Conference Room at Electro-Technical Services , Loch Street , Newtown , on 21 October 2025 , starting at 11:00 .
