A non-refundable fee of R250 (Two Hundred and Fifty Rand), is payable for a set of documents. Sealed Bids, marked: **“BID SCM: 21/2024: REQUEST FOR PROPOSAL: APPOINTMENT OF A PANEL FOR THE SOURCING OF CAPITAL FUNDING IN LINE WITH APPLICABLE LEGISLATIVE GUIDELINES”** must be addressed to the Municipal Manager and placed in the tender box at the Offices of the Supply Chain Management Unit: Corporate Services in the Sanlam Building, 112 Donkin Street, Beaufort West, before the closing time and date of **14:00 on Friday, 02 February 2023**. Bids will then be opened in the presence of anyone who wishes to attend, in the Committee Room in the Supply Chain Management office at the Sanlam Building, Donkin Street, Beaufort West.

Telegraphic, telephonic, telex, facsimile, e-mail, bids not completed in ink by hand and late bids will not be accepted. The municipality is not bound to accept the lowest bidder and the Council reserves the right to accept any part of the bid or cancel the bid.

The bid must be valid for a period of 120 (one hundred and twenty) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, Preferential Procurement Policy, the Preferential Procurement Policy Framework Act, and the Preferential Procurement Regulations, 2022. Points will be allocated for the following specific goals: (a) contracting with persons, or categories of persons, historically disadvantaged by unfair discrimination on the basis of race, gender or disability; and (b) promotion of enterprises located in the municipal area (WC053). The 80/20 preference points system will be applicable.
