The BEAUFORT WEST MUNICIPALITY hereby invites contractors to submit formal written quotations for the Refurbishment Of Netball Ablution Facility In Murraysburg.

It is estimated that the contractor should have a CIDB grading designation of 2GB or higher.

Only Tenderers with experience in the REFURBISHMENT OF BUILDINGS are eligible to submit tenders.

A compulsory site meeting will be held at the Murraysburg Town Hall, on Thursday, 27 November 2025 at 12:00. Hard copies of bid documents must be booked in advance before Tuesday, 25 November 2025 and will be available at the compulsory clarification meeting. Formal written documents will then be opened in the presence of anyone who wishes to attend, in the Committee Room in the Supply Chain Management Office at the Sanlam Building, Donkin Street, Beaufort West.

Telegraphic, telephonic, telex, facsimile, e-mail, bids not completed in black ink by hand and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and Beaufort West Municipality reserves the right to accept any part of the bid.

The tender must be valid for a period of 90 (ninety) days after the closing date.

The tender will be subject to Council's Supply Chain Management and Preferential Procurement Policies. The 80/20 preference points system will be applicable. A maximum of 80 points will be awarded for Price and a maximum of 20 points will be awarded for the following Specific Goals:
