The BEAUFORT WEST MUNICIPALITY hereby invites electrical contractors to submit competitive bid for the supply, deliver, installation, refurbishment, relocation, testing and commissioning of various primary & secondary substations with associated equipment and works required for Beaufort West Municipality for 3 year period.

It is estimated that the contractor should have a CIDB grading designation of 6 EP or higher. A prerequisite of 70% exists for Functionality, in order to be further evaluated.
