Bids are invited by the Acting Municipal Manager of the BEAUFORT WEST Municipality from qualified service providers for the provision for inspection, certification and repair of lifting equipment for a period of three-years.

**A compulsory clarification meeting will be held at the Beaufort West Municipality Electrical Department, Loch Road, Newtown, Beaufort West on Tuesday, 31 March 2026 at 11h00. Documents will only be available for collection at the compulsory clarification meeting if tenderers booked their tender documents in advance, with proof of payment. Tenders should be booked before Monday, 30 March 2026 at 13:00. No tenderers will be allowed to attend the compulsory clarification meeting after 11:15.**

A non-refundable fee of R265 (Two Hundred and Sixty Five Rand), is payable for a set of documents. The fee must be deposited into the account of the Beaufort West Municipality at **NEDBANK, Branch Code: 198 765, Account Number 107 428 0318**. Bids will then be opened in the presence of anyone who wishes to attend, in the Supply Chain Management Committee Room in the Sanlam Building Shop Nr 7, Donkin Street, Beaufort West.

Telegraphic, telephonic, telex, facsimile, e-mail, bids not completed in black ink by hand and late bids will not be accepted. The lowest, only or any formal quotation shall not necessarily be accepted and Beaufort West Municipality reserves the right to accept any part of the bid.

The bid must be valid for a period of **120** (one hundred and twenty) days after the closing date.

The bid will be subject to Council's Supply Chain Management and Preferential Procurement Policies. The 80/20 preference points system will be applicable. A maximum of 80 points will be awarded for Price and a maximum of 20 points will be awarded for the following Specific Goals:
