Notice is hereby given in terms of Section 4(3)(a) of the By-Law Relating to the Management and Administration of the Municipality's Immovable Property that the Local Council intends to lease the passage situated at erf 4356, between Leliestraat and Dorahlaan to Mr. JM Anthonie at R1.00 per year for a period of (9) nine years and (11) eleven months in order to close the passage.
